The principal objective of the project is to provide energy with a reasonable price for the investment sector (Industrial, agricultural or commercial) as well as the household sector. This objective is in line with the Ministry of Electricity and Renewable Energy policy of providing the electrical energy to all consumers in Arab Republic of Egypt.
